Position Summary

Operates in a diverse environment to help fulfill the Library's mission and strategic goals by providing comprehensive, patron-focused public services, planning/conducting services, and participating in targeted activities for designated children aged 9 - 14 years old and their caregivers. This position requires flexibility, collaboration, communication, and the ability to identify priorities and shift focus quickly.

Essential Functions

Functions listed are intended only as illustrations of the various types of work performed. The omission of specific duties does not exclude them from the position if the work is similar, related or a logical assignment to the position.

- Plans and conducts programs, classes, and trainings District-wide for children ages 9 - 14 years old and their caregivers.
- Provides consultation to Library staff for tween and teen spaces at the library.
- Plans, coordinates, and implements the Jean Ciavonne Poetry Contest.
- Provides leadership for Summer Adventure, the PPLD's summer reading program and largest initiative. Maintains the budget, purchases age-appropriate books and incentives, creates training, serves as PPLD's Beanstack administrator, and acts as a liaison with partnering organizations.
- Provides leadership and guidance for standardized, centralized programming. Creates and compiles all documentation for 15 library locations. Serves as a liaison between multiple departments.
- Maintains the PPLD Tween webpage, reading list, LibGuides, and resources.
- Serves as a PPLD ambassador to schools in El Paso County. Attends outreach events, classroom visits, and other community outreach.
- Coordinates District-wide meetings with Family & Children Services.
- Supports Young Adult Services through intergenerational programs.
- Promotes library services through tours, demonstrations, talks, and displays.
- Compiles and analyzes data and research to assist with decision-making; makes recommendations for new initiatives or solutions to challenges specifically children and focusing on 9-14 year old. Anticipates challenges due to seasonal workflow, emerging technology, and evolving community dynamics; helps set priorities for adapting to systemic change.
- Provides excellent customer service and maintains a courteous, positive image of the Library; maintains confidentiality in all patron and staff interactions; models exemplary customer service behaviors for Library staff.

Additional Duties and Responsibilities

Duties are considered non-essential and include the following:

- Keeps informed about library and department information.
- Attends regular department meetings, including Young Adult Services meetings, and scheduled All-staff meetings.
- Plans and conducts professional development for library staff throughout Colorado.

- May act as person-in-charge as assigned; assumes responsibility for safe and effective operation of the library; ensures that security and safety reports are completed accurately and submitted as required.
- Performs other job-related duties as assigned.

Required Knowledge, Skills, and Abilities

The employee is expected to perform or possess the following:

- Thorough knowledge of the Pikes Peak Library District's policies and procedures and ability to follow them.
- Ability to act as an ambassador of Pikes Peak Library District by promoting its mission and vision to the public.
- Demonstrates thorough knowledge of library trends, processes, and best practices.
- Demonstrates flexibility to actively support change in order to meet strategic goals and objectives.
- Demonstrates excellent verbal and written communication skills; maintains effective relationships with patrons, coworkers, and with staff at all levels.
- Demonstrates commitment to principles of intellectual freedom and all aspects of customer diversity.
- Ability to work independently and effectively organize daily work under general supervision.
- Ability to effectively train others.
- Ability to work as part of a team, demonstrating an excellent customer service attitude.
- Demonstrates ability to effectively use applications software, including Microsoft SharePoint, Word, Excel, SmartSheets and Outlook, Integrated Library System, along with standard office equipment.
- Demonstrates ability to exhibit sound judgment and demeanor in public interactions; thinks and acts appropriately under pressure.
- Demonstrates ability to work effectively as a team member, organize daily work and meet deadlines in a fast-paced, detail-rich environment.
- Has regular on-time attendance.
- Exercise professionalism and good judgement in interpersonal interactions.

Education and Experience:

1. Requires a Master's degree in library science or library information science.
2. Requires a minimum of two years of library experience.
3. For some positions, experience in working with foreign language materials and/or specialized formats and equipment is preferred.
4. Bilingual ability is a plus in serving a diverse community

Physical and Environmental Conditions:

Work is primarily conducted in an office setting that provides comfortable lighting, temperature, and air conditions. Position requires the ability to sit and use a computer or standard office equipment for extended periods. Position requires the ability to stand for extended periods of time. Position requires the ability to occasionally reach, bend, climb, twist and squat. Position requires the ability to lift up to 35 pounds. Position requires the ability to push a loaded book truck.

Conditions of Employment:

All selected candidates...
