[Loans Available for Nonprofits in the CARES Act](#)

The Coronavirus Aid, Relief, and Economic Security Act CARES Act (Pub. L. 116-132) defined a number of programs that charitable nonprofits will be eligible to apply for. The chart below provides information on those loan options, eligibility criteria, terms, and application information. This chart is neither financial nor legal advice for any specific organization. | Description | Emergency loan program for nonprofits and for-profit entities to secure funds to pay staff and operating costs for two months, and secure full loan forgiveness under certain circumstances. | Existing Economic Injury Disaster Loan (EIDL) program expanded to more for-profit entities, applies looser credit standards, and creates a rapid grant procedure. | Largely undefined loan program to be created by the Treasury Department to fill the gap between the Paycheck Protection Program for smaller employers and the industry stabilization loans to big business. |
| Size Eligibility | 500 or fewer employees | Existing EIDL limits for nonprofits* | Between 500 and 10,000 employees |
| Dollar Amount | The lesser of \$10 million or 2.5 times the average total monthly payroll costs from the one-year period (look back) prior to the date of application.
